Pursuant to Articles 4 (2) (2) and 5(3) of the Law on Feed of the Republic of Lithuania and the points 5, 18, and 34 of the Description of the Procedure for Registration of the Feed Business Entities, approved by the order No. 3D-607 "Regarding the Approval of the Description of the Registration Procedure of the Feed Business Entities" of the Minister of Agriculture of the Republic of Lithuania of the 30th of December, 2005, and after evaluating the request submitted by UAB "Vetma" on the 2nd of May, 2023:

I am amending Point 1 of the Order No. 33[V-1572, "Regarding the Registration of the Feed Business Entity" of the director of the Kaunas Department of the State Food and Veterinary Service of the 5th of December, 2022, and I present it as follows:

- "1. I am supplementing the UAB "Vetma" activities, registered address at Birželio 23-iosios g. 23 G, Kaunas, legal entity code 300557995, a feed business entity, with the following feed handling activities:
 - r LT PLA 294088, activity storing feed (PLA), at Plento g. 6, Užliedžiai Village, Kaunas District;
- **r LT IKPT 294502**, activity importing combined feed (IKPT) into the Republic of Lithuania, at Plento g. 6, Užliedžiai Village, Kaunas District.
 - 2. I entrust:
- 2.1. the state feed supervision of the feed business entity specified in Point 1 of this order to the Chief Veterinarian-Inspector of the Kaunas Department of the State Food and Veterinary Service responsible for state feed supervision;
- 2.2. the execution control to the Counselor of the Kaunas Department of the State Food and Veterinary Service, responsible for the area of animal welfare and health.
- 3. I inform you that within one month from the date of receipt of this order, you can file a complaint to the State Food and Veterinary Service, located at Siesikų g. 19, Vilnius, or to Kaunas District Department of the Lithuanian Administrative Disputes Commission, located at Laisvės al. 36, 44240 Kaunas, or to Chamber of Kaunas of the Regional Administrative Court, located at A. Mickevičiaus g. 8A, 44312, Kaunas, in accordance with the procedure established by the Law on Administrative Proceedings of the Republic of Lithuania.
